



Works completed in previous 12 weeks

- Removal of temporary works continued.
- Continued column concrete pours.
- L2, L3, L4 and L5 slab pours completed.
- North core pre-cast construction completed.
- Goods hoist installed to level 3.
- Tower Crane 2 was erected.
- Tower Crane 1 was dismantled.

12 week look ahead

Scheduled works for the next 12 weeks

- **Superstructure**
 - Post-tensioned slabs will complete.
 - Concrete column pours will complete.
 - Brickwork and blockwork will continue throughout all floors.
 - MEP installation will continue throughout all floors.
 - UKPN room works will complete.
 - Façade works to commence.
 - Window installation to commence.
 - Primary steelwork to commence to Feature Staircase.
 - Drylining to commence.
- **Temporary works**
 - Removal of No. 36 Sackville Street steel work.
 - Removal of façade retention steel work in sequence.
 - Perimeter scaffold will continue.
 - Goods hoist to progress in line with building.

Community engagement



Initiatives

- McLaren have introduced Alex Talks our Community Liaison Coordinator. Alex will be taking the lead on all community matters, answering all queries relating to the project and ensuring all members of the community are communicated to with updates and relevant information in a timely manner.
- Inspections of the site boundary will be completed daily. Any observations and required actions will be recorded. Alex will also respond to any observations reported by 3rd parties.
- Newsletters and CLG meetings will continue.
- McLaren will be issuing notification to local residents of Saturday works in advance of them taking place with a four week look ahead issued at the same time.
- The works have been sequenced to complete the blockwork on Sackville St. and Albany Court as early as possible to create an additional acoustic and dust barrier.
- Over the coming weeks and months McLaren will constantly review the operations and look at new initiatives to support the community, we will continue to use this meeting as an opportunity to share them.


